Inpatient admission order is written based on the expectation that the patient will require at least 1 more midnight in the hospital for medically necessary hospital care. 12/9/2013 • 10:00 am - The patient's acute CHF exacerbation is resolved and she is discharged home. Hospital may bill this claim for inpatient Part A payment.

Inpatient Admission and Medical Review Criteria

According to the AAP* patients who meet any one of the following criteria should be re-fed in hospital rather than an outpatient setting (other criteria may pertain, clinical judgment required): <75% ideal body weight, or ongoing weight loss despite intensive management

Intensity of Service: (inpatient need) Note: BY CHIEF COMPLAINT: The below chief complaints are among the most common admitting diagnoses. The information contained in each represent the criteria to meet interqual for observation and inpatient level of care. Higher levels of care like stepdown or ICU usually have fewer issues meeting interqual.

Azar that over-reliance on MCG and InterQual created the basis for granting appeal rights to a class of patients hospitalized under observation. Certain patients hospitalized under observation may have had their due process rights violated by applying MCG and InterQual in admission status decisions.

Other resources as necessary are used to help in determining review decisions, these include, but are not limited to, Medi-Cal (State of California) guidelines and PHC internally developed and approved guidelines.

When you're put in the hospital, you're assigned either inpatient status or observation status, which is an outpatient designation. You're assigned inpatient status if you have severe problems that require highly technical, skilled care.

An Explanation of Inpatient vs. Observation Status

Issue: Inpatient Rehabilitation Admission . Solution: Be sure your inpatient rehabilitation admission is reasonable and necessary. Verify and document that the patient requires, can tolerate, and can significantly benefit from an intensive rehabilitation therapy program delivered in a hospital inpatient setting.
